### WINNEBAGO COUNTY BOARD OF SUPERVISORS September 25, 2018

The Winnebago County Board of Supervisors met in session at 9:00 A.M. September 25, 2018 adjourned from September 18, 2018.

On a motion by Jensvold and seconded by Durby the Supervisors moved to approve the minutes for the September 11, 2018 Board Meeting and approve the agenda for September 18, 2018. All voted aye. Motion carried.

Julie Swenson, Treasurer discussed tax sale property in the City of Rake. On a motion by Stensrud and seconded by Jensvold the Supervisors moved to give James Joebben until Thursday, September 27, 2018 to pay the tax sale or the Treasurer will deed the County held property to Rake. Brian Chatfield called in and spoke to the Supervisors regarding bridge timbers he purchased from the Secondary Road auction held in April, 2018.

Aiden & Marie Kelly, landowners discussed a drainage issue along their driveway. They feel there is a problem with the tile as the water does not drain in a timely manner. Drew Sweers, Veenstra & Kimm was hired to investigate the issue. Based on what he saw and what he has researched Sweers feels the most cost effective option would be to raise up the driveway. He feels this area is a low spot which will always pool water in heavy rains. To enlarge the pipe size would be an improvement and may not be approved by other landowners in the area. Sweers will check an intake in the field to see if it can be lowered.

On a motion by Jensvold and seconded by Durby the Supervisors moved to approve the letter of withdrawal from County Social Services. All voted aye. Motion carried.
