ORDINANCE NO. 3-2-13 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF RAKE, IOWA, 50465, BY ADDING A NEW SECTION MAKING FAILURE TO ABATE A VIOLATION UNDER CITY ORDI-NANCE

BE IT ENACTED by the City Council of Rake, Iowa: SECTION 1. NEW SECTION.

The Code of Ordinances of the City of Rake, Iowa, 50465 is amended by adding a new section 3-2-13, entitled FAILURE TO ABATE which is hereby adopted to read as follows: 3-12-13 FAILURE TO ABATE.

Any person causing or maintaining a nuisance who shall fail or refuse to abate or remove the same within the reasonable time required and specified in the notice to abate is in violation of this Code of Ordinances.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision thereof not adjudged invalid or un-
